Admissions requirements

Course aims

Are you passionate about live performance, but equally interested in literature? Study in central London, at the heart of the city's vibrant cultural scene, with BA Theatre and English at Birkbeck. Investigate theatre as live event, as dramatic text, and in its historical contexts, alongside a deep focus on the written word.

Your in-depth exploration of theatre histories and theories complements and expands your study of literatures in English. You will analyse techniques and practices of storytelling on the stage and on the page, garnering a detailed knowledge of dramatic and literary works from the medieval period to the present. Option modules allow you to focus on authors, genres, periods and practices from Shakespeare to science fiction, and to create theatre as an artist and writer if you wish.

Throughout your degree, you will visit the world's most exciting theatre institutions and analyse live and digital performances. Your final full-length dissertation project examines a topic of your choosing under the guidance of our world-leading academics.

BA Theatre and English at Birkbeck brings you the best of both worlds of theatre and literature.

This programme is also available for part-time evening study over four years, or with a foundation year.

Course aims:

- Enable students to develop knowledge and skills relating to theatre and English as domains of culture, politics and criticism
- Expand and develop students' knowledge of a range of theatre, performance and literary texts and practices from the ancient to the contemporary in local, national and international contexts
- Introduce and extend students' understanding of the histories and conventions that pertain to theatre and English
- Enable students to engage with critical and theoretical literature and debates in theatre, performance, English and cognate disciplines
- Develop students' knowledge of the reciprocity between theatre and performance practices, literatures in English, and their cultural, social, historical and political contexts, and in relation to key issues of identity, politics, and society
- Extend students' awareness of the key elements of practice and production in theatre and performance
- Develop students' knowledge of a range of textual forms (including poetry, drama, novels, short stories, graphic novels) and genres (such as tragedy, comedy, the gothic, science fiction, romance, life-writing)

- Provide students with a broad understanding of processes of research, interpretation, critical reflection and analysis
- Enable students to develop the intellectual tools to analyse and think critically about theatre, performance and literatures in English and their histories, and to develop independent critical judgement
- Support and facilitate students' development of skills in reading, research, writing, and creative process
- Offer students the opportunity to undertake and complete an independent study project based in theatre
- Offer a balanced programme of study that mixes compulsory modules and flexible option choice to enable students to engage with theatre, performance and literatures in English in a range of contexts
- Produce well-rounded graduates equipped with subject-specific and transferable knowledge and skills relevant to a range of sectors (including but not limited to arts and culture, education, law, marketing and public relations, charitable and third sector organisations, the public sector)

How you will learn

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

Learning on BA Theatre and English makes use of a mix of techniques and strategies, including:

- Lectures
- Seminars

- Workshops
- Tutorial support
- Independent visits to theatrical performances
- Independent study and research
- · Group-based study and research
- Access to public events hosted by Birkbeck Centre for Contemporary Theatre.

Students will learn primarily through the three key pedagogical practices central to Theatre and English at BA level: lectures, seminar discussions and workshops. Lectures provide students with key information regarding topics or themes. Seminars are interactive, and involve students' advance preparation of materials, often focused by a series of set questions or prompts. Workshops enable students to explore the concepts they are introduced to in seminars and lectures through hands-on exercises involving the use of skills in close reading, writing and analysis. If practice-based theatre options are selected, these take a 'laboratory' approach, whereby students test and investigate practical strategies, effects and outcomes of theatre and performance through practice. This process of learning will be supplemented by independent research (involving the use of libraries, internet resources, and archives), independent individual and group work, and theatre visits.

How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

Assessment methods include:

- Research essays
- Research exercises
- Presentations
- Creative projects (where relevant)
- Critical reflections
- Group vivas (spoken examinations)
- Individual vivas (spoken examinations)

Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Demonstrate knowledge and understanding of the key traditions, conventions, contexts, histories, concepts, cultures and institutions that comprise theatre, performance and English;
- 2. Show awareness of the range and variety of key critical and theoretical debates at the forefront of the fields of theatre, performance and English:
- 3. Demonstrate knowledge and understanding of the interplay between practice and theory;
- 4. Evidence ability to describe, theorise, interpret, analyse, historicise and evaluate theatre, performance and literary texts and events from a range of critical perspectives;

- Utilise research skills, including the ability to gather, sift and organise material independently and critically and to present it in the form of an essay, report, presentation or creative piece
- 6. Discuss and evaluate your own work and the work of fellow students
- 7. Work efficiently and constructively within a group and on an individual basis to realise presentations of a specified length;
- 8. Present and sustain arguments and engage in debate;
- 9. Act as a reflective, self-directed learner, recognizing and employing a range of strategies to support independent learning, including an awareness of strengths/weaknesses.
- 10. Communicate in public and in working groups with expressive clarity and sophistication;
- 11. Apply the expressive, critical and evaluative skills acquired during the programme to varied kinds of work;
- 12. Communicate ideas and arguments clearly in a variety of oral, written, visual and performance media;
- 13. Demonstrate some IT skills; the use of libraries and electronic sources of information, online discussion groups, web-based research, e-learning, word-processing;
- 14. Utilise bibliographical skills appropriate to the discipline, including accurate citation of sources and consistent use of conventions in the presentation of scholarly work.

Careers and further study

Employers highly value the analytical, critical, communicative, and interpersonal skills that a Birkbeck degree in Theatre and English can offer. Theatre and English graduates leave with valuable attributes such as:

- High-level oral and written communication skills in English
- The ability to work efficiently and effectively as part of a team and on an individual basis
- Research skills
- Skills in analysis and argumentation
- Skills in evaluating and assessing ideas and information
- The ability to articulate yourself clearly, cogently and persuasively

tutor and provided with information about learning support offered within your School and by the College.

Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Each new course or module is subject to a course approval process where the proposal is scrutinised by subject specialists, quality professionals and external representatives to ensure that it will offer an excellent student experience and meet the expectation of regulatory and other professional bodies.

You will be invited to participate in an online survey for each module you take. We take these surveys seriously and they are considered by the course team to develop both modules and the overall courses. Please take the time to complete any surveys you are sent as a student.

We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.
