## Admissions requirements

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential.

## **Course aims**

The BA Art History with Curating helps you to develop a range of key skills, from critical thinking and writing, to historical research and visual analysis. We will explore the cultural and political contexts of artworks and exhibitions, and think more broadly about the role of images within society. You will have the opportunity to plan and pitch an exhibition. Our modules make a creative use of the art galleries, museums and other facilities in London and beyond, including a study trip abroad in spring.

We teach art history as a rich and dynamic topic, encompassing exhibitions, installation, print culture, and digital media as well as painting, sculpture and photography. You will be taught by brilliant teachers who are also published writers of ground-breaking art history in periods from medieval to contemporary, and have curated exhibitions in diverse settings.

You will be part of a diverse, vibrant and stimulating student community in central London. Our evening classes allow you to combine studying with work or taking up volunteering opportunities during the day, and the programme will support you in making the first steps towards working in the arts. Alumni of the department now work in a variety of arts and art-related organizations, or progress to postgraduate studies.

## The programme aims to:

- Offer a structured programme of intellectually stimulating and challenging modules which provide a sound training in Art History and an introduction to Curating practices
- Offer students the opportunity to develop a range of transferable skills
- Offer a broad range of learning experiences
- Provide relevant courses for those working, or seeking to work, in the visual arts, and opportunities to develop subject-specific skills

## How you will learn

Your learning and our teaching are organised to help you meet the learning outcomes of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about the programme overall and each of your modules: what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed, how to communicate with lecturers and your peers.

Your learning for this course is organised around a combination of interactive lectures, seminars, and visits to art museums and galleries. Interactive lectures are designed to allow you to engage with an outline or overview of the topic, with the visual and textual material related to the session, and direct you to other resources. They are a springboard for your own learning. Seminars are group sessions where you will be asked to contribute to discussion or group work around the topic, with material set in advance for which you need to prepare. Visits are guided or organised by you with your peer group, and form an integral part of some of the modules.

## How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. We use a variety of assessment methods. For most of the modules associated with this course, your assessment will be through the following types of assessment:

- Short written exercises, including social media posts and take-home exams
- Essays which will develop in length as you progress through your studies
- Oral and visual presentations about your written work

## Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

By the end of this course you should be able to:

- Demonstrate a general knowledge of the history of art and detailed knowledge of specific themes, periods or places.
- Observe and analyse works of visual culture, orally and in writing.
- Demonstrate a critical awareness of the functions of such works within the social and cultural contexts of their production and reception.
- Demonstrate familiarity with current debates and approaches to the discipline.
- Use effective skills of visual perceptiveness, of critical reading of texts and images, of analysis, debate and communication, in your written work and oral presentations.
- Take responsibility for your own learning by undertaking independent research.

## Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Each new course or module is subject to a course approval process where the proposal is scrutinised by subject specialists, quality professionals and external representatives to ensure that it will offer an excellent student experience and meet the expectation of regulatory and other professional bodies.

You will be invited to participate in an online survey for each module you take. We take these surveys seriously and they are considered by the course team to develop both modules and the overall courses. Please take the time to complete any surveys you are sent as a student.

We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.

Programme specifications are reviewed periodically. If any changes are made to courses, including core and/or compulsory modules, the relevant department is required to provide a revised programme specification. Students will be notified of any changes via Moodle.
