# Admissions requirements

We welcome applicants with a wide range of previous experience and qualifications. A second class honours degree (2.2 or above) in a Humanities subject satisfies the standard requirement, but we do base decisions on our own assessment of qualifications, knowledge and previous work experience. We may request writing samples or further interview to gauge academic potential in instances where non-traditional education and experience may merit the waiving of formal entry requirements.

# **Course aims**

Our European History MA programme encourages you to delve into the historical evolution and contemporary complexity of Europe, a space that can be variably defined by geography, ideology, culture, or other criteria. Rather than presuppose one all-encompassing definition of 'Europe', the course highlights the different contexts within which European pasts and presents can be analysed. You will study at a department with world-renowned expertise in the broad expanse of European history, from Britain to the Balkans, from the Baltic to the Mediterranean, and in international, transnational, global and comparative historical perspectives. The course develops new approaches to the history of Europe from the early modern period to the present day. It provides you with an appreciation of key debates that have shaped our understanding of Europe and the most important historical and methodological approaches to critically interpreting the past.

# **Course structure**

NB All core and compulsory taught modules will be delivered using hyflex technology (with live synchronous in-person and online seminars). Each year, there will be a selection of options available in delivery formats that enable students to study either an in-person, online or flexible route through the programme.

#### How you will learn

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, you are expected to be an active learner and to take responsibility for your learning, engaging with all the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

Teaching on this course includes lectures but is predominantly structured as seminars, or discussion-focused group sessions. In the introductory module 'Mastering Historical Research:

Birkbeck Approaches', lectures from our internationally-recognised staff will introduce you to critical ideas, debates and figures of the past, while seminars in this and subsequent modules will train you in the construction of collaborative knowledge alongside the diverse community of your fellow students. You will also deepen your subject knowledge and sharpen your critical skills through extensive reading and other forms of independent learning. Modules across the programme include the analysis of primary and secondary text sources, as well as images, material culture, music and film.

All compulsory/core modules will be delivered Hyflex along with a selection of options, allowing students to learn in person, online, or to move between these modes as part of our Flexible Learning offer.

# How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

History modules normally incorporate diverse forms of assessment, including shorter, mid-term written exercises such as source analyses or literature reviews; oral presentations; and end-of-module research essays. Assignments grow in complexity across the term, offering the reassurance of guided progression towards the research essay, and tailored writing support is available within the department and at college level for students who might benefit from additional advice. To complete the degree, you will design, research, and write a dissertation.

# Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Critically analyse narratives about the past and its role in the present across a range of contexts
- Understand and interrogate primary sources (from the past) and secondary sources (about the past) in discussion and writing
- -Read and use historical scholarship at a high academic level
- -Discuss texts, objects and diverse media with a group of your peers
- - Present your own research and arguments orally
- -Design your own research questions and programme of research
- -Navigate archives, collections, oral history sources, and libraries
- -Carry out research and writing at multiple scales: response essay, research essay, dissertation
- Engage with communities of historians, from academic workshops and conferences to public historians to your local community
- -Gain skills suited to design and create disseminations of your research in multiple forms, from article to podcast to public lecture

#### Careers and further study

The MA European History prepares you for any role which benefits from skills in research, communication and engagement. Graduates of our programme work across professions and

disciplines, from education to business to the arts, from museums and galleries to the heritage sector, from journalism to government, from social work to non-governmental and charitable organisations. Graduates interested in further study have gone on to complete research degree (MPhil/PhD) programmes.

Birkbeck's MA European History graduates will complete with a set of valuable attributes, for example:

- High-level oral and written communication skills in English

- Skills in evaluating and assessing types of information
- The ability to present yourself and an argument

#### **Quality and standards at Birkbeck**

This supports the accessibility of our education including expectations of what information is provided online for students.
