Admissions requirements

- Applicants should have at least a 2:2 or equivalent in their first degree. Admission is at the discretion of the admissions tutor.
- Applicants are required to demonstrate that they meet the College's English language requirements.
- Credit for previous equivalent law studies may allow transfer into Year 2 at the discretion of the admissions tutor.

We may waive formal entry requirements based on judgement of academic potential.

Course aims

The LLM QLD is designed both for those who wish to pursue a career in Law as well as those with an academic interest in the subject - providing a comprehensive grounding in the seven foundational subjects of English law and extend students' legal knowledge and understanding in specialist areas.

Professional Qualification

The programme satisfies the first stage (academic) of professional qualification laid down by the Bar Standard's Board (http://www.barstandardsboard.org.uk/) and the Solicitor's Regulation Authority (for those who began their degrees before 01 September 2022) (http://www.sra.org.uk/home/home.page). It also provides a foundation for the functional legal knowledge tested on the Single Qualifying Exam (Part One) set by the Solicitor's Regulatory authority.

Students who successfully complete study of the LLM/QLD are guaranteed progression to the University of Law, which provides short and long courses to prepare students for sitting the Single Qualifying Exam (parts one and two).

Academic

The LLM QLD will provide students with a rigorous academic experience satisfying the requirements of the University of London at the master's level. More specifically the programme aims to:

- provide postgraduate degree programmes which give a comprehensive grounding in foundational subjects of English law and extend students' legal knowledge and understanding in specialist areas;
- provide students with a deep understanding of major legal concepts, values, principles and rules of the legal system, legislation and case law;
- provide a broad appreciation of the range of possible approaches to legal scholarship;
- promote a multi-disciplinary approach to the study of law at masters level, which enables students to make use of theoretical frameworks developed in law, the humanities and social sciences;
- place the study of law within its historical, ethical, social, political, cultural and economic context;
- provide students with knowledge of a representative range of contemporary debates in law informed by an awareness of how the law has developed over time;
- bridge the gap between students' understanding of the theory and practice of law;
 enable students to identify, locate and appraise legal materials
- provide students with a range of subject specific and transferable skills which develop their capacity to learn, meet the needs of the wider society and prepare students for employment or further studies. These include IT literacy and the ability to work independently and in a group.

Distinctive Features

The LLM QLD course has two distinctive features. The first feature is that it is a qualifying law degree at postgraduate level. The conventional qualifying law degree programme in the UK is an LLB, which is at undergraduate level. Another route to qualification is the GDL, a one-year conversion course that teaches postgraduates students the basic rules of law in preparation for the courses and examinations set out by the relevant regulatory bodies. Our LLM QLD programme both gives students a rigorous theoretical understanding of law, deeper than a GDL course would, while preparing them to enter into the legal profession as practitioners. The second feature is its structure of teaching is designed for students who need to balance study with paid work, family or other commitments but desire to study in an environment led by academic staff with extensive research expertise and publications in the field of study. Specific features include:

- All compulsory classes are taught between 6pm and 9pm, Monday –Thursday
- Flexible pathways of study, enabling completion within a minimum of two and a maximum of three years.
- Choice of studying in-person, or online.
- The option to complete a supervised Research Project
- Access to optional modules in the fields of human rights, criminal justice, commercial and legal practice as well as to a range of distinctive optional subjects relating to the research of academic staff.
- For online students, the course offers enhanced flexibility, whereby students may study at their own pace during the week.

How you will learn

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

The School of Law employs a variety of teaching and learning strategies to enable learning outcomes to be achieved. In particular we promote student learning through lectures (prerecorded and in person); seminars; virtual learning environments including online seminars; student led study groups facilitated by the school and made available to remote students; private tutorials; web based independent skills tutorials; weekend and pre-sessional skills workshops; public lectures and research seminars. We employ a diversity of assessment tools including independent research essays, take home exams, group work, oral presentations, reflective journals and creative and critical thinking exercises.

For students studying the course fully online, all compulsory and optional modules will be taught through the same mixture of pre-recorded lectures and face-to-face live online teaching sessions as is the case with the in-person iteration of the course (ie., students will receive a minimum of 1.5 hours of face-to-face teaching per week for each course taught; although the 15 hours of face-to-face teaching per term per course may, for some modules, be delivered in more condensed teaching blocks).

All assessment methods used on the programme can be completed at distance. A mix of assessments are used, for example, on-line exams (delivered in 48 hours); research essays; inclass assessments, including completion of problem question; as well as, formative/cumulative assessments (eg workbooks completed over the course of study).

How we will assess you

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment:

Short written exercises, essays which will develop in length and expected complexity as you progress through your studies, quizzes and multiple-choice questionnaires, practical assessments (of your work in a lab/studio), case studies, problems to solve.

Learning outcomes (what you can expect to achieve)

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

- Demonstrate General law related skills
- Identify, explain and critically assess the main characteristics of the legal system, including general familiarity with its institutions and procedures;
- Present a sound and accurate understanding of the detail of the law and its context in relation to most areas of law studied:
- Identify and demonstrate depth of knowledge of some of the political, economic, commercial, social and cultural factors that inform and underlie legal theory and doctrine;
- Understand complex aspects of the problems, tensions and contradictions within certain legal theories and doctrines;
- Identify and critically analyse contemporary legal debates.

Subject specific skills

- Demonstrate systematic knowledge and understanding of a wide range of legal concepts, values, principles and rules of English law and an ability to explain the relationships between them in a number of particular areas,
- Accurately state the law in key areas of foundational subjects, including but not limited to: Constitutional and Administrative Law, Contract Law, Criminal Law, Tort, Law, Property Law, Equity Law, and Law of the European Union
- Demonstrate the ability to critically discuss contemporary public and scholarly debates which are relevant to law in the UK Transferrable skills
- Demonstrate research and writing skills in the context of writing a postgraduate Research Project
- Demonstrate self-direction in formulating an original research question and independent learning ability suitable for writing a postgraduate Research Project

Careers and further study

Graduates can pursue career paths in the legal profession, or use the degree to develop their existing career, further their academic skills, or prepare for a research degree. Many of our graduates go on to vocational training and obtain solicitors' training contracts and pupillages in barristers' chambers. Possible professions include:

- barrister
- solicitor
- patent attorney
- barrister's clerk.

Academic regulations and course management

Birkbeck will introduce you to the Library and IT support, how to access materials online, including using Moodle, and provide you with an orientation which includes an online Moodle module to guide you through all of the support available. You will also be allocated a personal tutor and provided with information about learning support offered within your School and by the College.

Quality and standards at Birkbeck

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Each new course or module is subject to a course approval process where the proposal is scrutinised by subject specialists, quality professionals and external representatives to ensure that it will offer an excellent student experience and meet the expectation of regulatory and other professional bodies.

You will be invited to participate in an online survey for each module you take. We take these surveys seriously and they are considered by the course team to develop both modules and the overall courses. Please take the time to complete any surveys you are sent as a student.

We conduct an annual process of reviewing our portfolio of courses which analyses student achievement, equality data and includes an action plan for each department to identify ongoing enhancements to our education, including changes made as a result of student feedback.

Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.

The information in this programme specification has been approved by the College's Academic Board and every effort has been made to ensure the accuracy of the information it contains.

Programme specifications are reviewed periodically. If any changes are made to courses, including core and/or compulsory modules, the relevant department is required to provide a revised programme specification. Students will be notified of any changes via Moodle.
